**Position Details:** The Wilson Creek is seeking a 1<sup>st</sup> / 2<sup>nd</sup> Grade Combination Classroom Teacher. The district is looking for a positive and enthusiastic certificated teacher who is not only endorsed to teach primary grades, but who also has experience in teaching young children with rigor and high expectations in a fun learning meaningful manner, while creating a positive learning environment that is well managed. **Applicants must hold or be eligible for an active Washington State Teaching Certificate.**

Wilson Creek is a small school district located approximately 30 miles north of Moses Lake and 20 miles east of Ephrata. With an enrollment of just 120 students from preschool through 12th grade, our district serves a rural farming community, drawing students from within a 25-mile radius. Nearly 60% of our students are choice students, giving our school a unique feel that is often compared to a private school environment. We are especially proud of our decades-long tradition of achieving a 100% graduation rate.

The Wilson Creek School District operates on a four-day school week and offers a supportive, student-centered work environment. Teachers enjoy the opportunity to work with small class sizes of 18 students or fewer, provide individualized and targeted instruction, and collaborate with a caring, professional staff dedicated to student success.
